*I, ..... agree to provide a urine sample for analysis for the detection of banned substances in accordance with the INBA Doping Policy. I fully understand that a condition of entering this contest was that I have not taken any banned substance for five (5) years prior to this competition. I agree that if I produce a positive test result to a prohibited substance, I will pay a fee of \$2000.00 within seven days to the International Natural Bodybuilding Association (INBA) to reimburse the cost of my drug test and to redistribute trophies and results. If I pass the test, I have fulfilled the condition of entry and the INBA shall pay all costs.*

Also, as a member of the INBA and/or a participant in an INBA authorized or recognized event, I hereby acknowledge and agree as follows:

- I have had an opportunity to review the INBA Anti-Doping Rules.
- To comply with and be bound by all of the provisions of this entry form and INBA Anti-Doping Rules and amendments.
- The INBA and National Federations have jurisdiction to impose sanctions as provided in the INBA Anti-Doping Rules.
- Any dispute arising out of a decision made pursuant to the INBA Anti-Doping Rules, after exhaustion of the process expressly provided for in the INBA Anti-Doping Rules, may be appealed exclusively to the Court of Arbitration for Sport.
- Decisions of the Court of Arbitration for Sport shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
